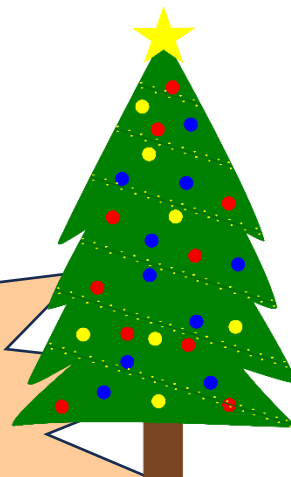

How to prepare for Fall/Winter

- Wrap outdoor and indoor pipes in unheated areas (like a clothes washer in your garage).
- Remove water hoses and wrap outdoor pipes.
- Drain and turn off your lawn sprinkler system.
- Turn off the water to your clothes washer if it's in an unheated garage.
- Store your lawn equipment in a garage or shed to keep it in good condition for next year.
- Insulate your pipes by closing outside doors and windows, and filling cracks in walls and around windows to eliminate cold drafts near water pipes. Heat up the pipes locally to avoid fissures, breaks, and other worse complications

STAGE 5

No Watering
All outdoor and non-essential uses of water are prohibited
